Goals:

- 1. Community Unity:** Strengthen bonds and maintain the sense of belonging.

Key Areas:

1. Community Impact:

- We aim to highlight the direct effects of proposed industrial developments, focusing on the financial, social, and environmental consequences.
- Our focus is local impact, not opposing renewable energy or climate change initiatives.

2. Financial Injustice:

- We will advocate against developments that result in financial harm, for example the NSW Valuer General's statement that land values may drop by at least 30% around turbines.

- We will call out and address the potential loss of community unity and the mental health challenges that arise from this large-scale development.

4. Safety and Environmental Concerns:

- We will highlight fire hazards and risks associated with turbine installations.
- We will advocate to protect our country's wildlife and ecosystems from development harm.

5. Fairness and Community Agency:

- We will call out the imbalance where small, everyday changes require community consultation, but large developments do not.
- Advocate for the right to have a voice in significant community changes.

Key Messages:

- **Fair Go for Our Community:** Demand that local voices are heard and respected.
- **Not Anti-Renewable, Pro-Community:** Our stance is not against climate action, but for balanced, community-centred decision-making.
- **Defending Our Future:** We aim to protect our community's financial stability, mental health, and natural environment.
- **Advocating for Honesty and Transparency:** Ensuring that our community is accurately informed and fairly treated.
